# National Service Criminal History Checks Vendor and Training Updates

## **Approved Vendor Updates**

### Reuse of Email Addresses on Fieldprint Scheduling Site

Fieldprint updated its website at <a href="fieldprintcncs.com">fieldprintcncs.com</a> to include new authentication for applicants when scheduling fingerprinting appointments. This authentication requires a unique email address for each applicant. We understand that some programs assist applicants to schedule their fingerprinting and use a single organization email address to complete scheduling for applicants who do not have their own email address. Due to the new authentication requirements, you can no longer reuse the same email address to schedule fingerprinting for different individuals with Fieldprint. You may assist applicants to create an email address for this purpose. Note that the scheduling process asks applicants for their preferred method of contact. Applicants may select phone, instead of email, as their preferred method of contact to receive notifications from Fieldprint about their appointment.

This fact will not change when Truescreen and Fieldprint are combined later this year. Although you will order checks, review, and adjudicate results in the Truescreen site, applicants will continue to schedule their fingerprinting appointments with Fieldprint.

As a reminder, you may assist applicants as they complete the online portion of the Truescreen and Fieldprint process, but program staff **must not** sign Truescreen or Fieldprint consent forms on behalf of applicants. **Applicants must be present to enter their information and complete their consent forms.**
